ORDER:

In the references first and Second read above, the Member Secretary, Gurukulam, (AP), Hyderabad has informed that there have been several representations received for considering for sanction of new Residential Schools / Ashram Schools in the areas in certain Districts / pockets in the State with areas of S.T population concentration that are not covered hitherto. The representations were examined thoroughly with reference to S.T. School-age population, availability of Institutions in the attachment areas etc and found only (6) cases feasible for considering for sanction of new Residential Schools / Ashram Schools and submitted detailed proposal for sanction to start Schools during the academic year 2003-2004.

2. The matter has been placed in the meeting of Council of Minister held on 3<sup>rd</sup> November 2003, after detailed discussion the Council of Minister have approved the proposal for sanction for starting the following (5) Residential Schools and (3) Ashram School along with teaching and non-teaching staff in the following pattern for one school required for maintaining the institutions at Visakhapatnam, Mahboobnagar, Nalgonda, Ananthapur, Nellore, Karimnagar, Warangal and West Godavari Districts.
