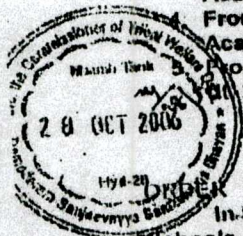

In the G.O. 1<sup>st</sup> read above orders were issued for sanctioning 5 Residential Schools & 3 Ashram Schools in various Districts of the State, wherein one Residential School for ST Girls at Kodavalur in Nellore District was sanctioned among others.

The Member Secretary, Gurukulam, Andhra Pradesh, Hyderabad in his letter 2<sup>nd</sup> read above has informed that there is a communication from Government of India that a Model Residential School for Girls in Nellore District is sanctioned and with this there are two schools sanctioned for Nellore District, one school by Government of Andhra Pradesh and the other by Government of India under Article 275 (1) Constitution of India. In view of this it is felt desirable to reallocate one of the two schools sanctioned for Nellore District to a District having no single Tribal Welfare Residential School. The Member Secretary, Gurukulam therefore proposed to reallocate the school sanctioned at Kodavalur (G), Nellore District, vide G.O. 1<sup>st</sup> read above.

The District Collector, Krishna District in this letter 5<sup>th</sup> read above has requested the Govt. to sanction a Residential School in Krishna District.

Government after careful examination, hereby shift the Residential school for Girls sanctioned at Kodavalur, Nellore District in G.O. 1<sup>st</sup> read above to Visannapeta, Krishna District.

The Director of Tribal Welfare, A.P., Hyderabad / Member Secretary, Gurukulam, Andhra Pradesh, Hyderabad is requested to take necessary action accordingly.
